**Guidelines for Reconstitution of District/City Level Vigilance & Monitoring  
Committee (DLVMC) of National Health Mission - Regarding**

*Refer to an Office Memorandum received from the MoHFW (GoI), National Health Mission; Dated 13/08/2014 regarding the subject cited above.*

You must be aware that the Parliament Cabinet approved the National Health Mission (NHM) in May 2013; with its two sub-Missions, i.e. National Rural Health Mission (NRHM) and National Urban Health Mission (NUHM). Accordingly, the MoHFW (GoI) has revised the guidelines for Re-constitution of DLVMC of NHM to involve key stakeholders of urban segments under the Mission (attached herewith). Therefore, now the DH&FWSs are also required to re-constitute the DLVMC in respective Districts.

2. In view of the General Elections of Lok Sabha (2014-15) all the existing MPs are also required to be informed about the existence and re-constitution of the DLVMC under their Hon'ble Chairpersonship. Now the DLVMC will monitor the progress of implementation under the overall NHM framework. The Committee will also review strict adherence to prudent fiscal norms, inter sectorial convergence, community participation and monitoring etc.

3. At the end of every quarter, the DH&FWSs are required to provide the detailed Status Reports and Record of Proceedings of the meetings of the DLVMC held as per the attached reporting format. The quarterly Progress Report should be furnished to State NHM HQ as per the following schedule, without any delay, as the same is required to be supplied to GoI by 31<sup>st</sup> day of each subsequent quarter:

Sr.	Quarter	Period Ending	Due Date for Receiving Report
1	1 <sup>st</sup> Quarter	April- June	15 <sup>th</sup> July
2	2 <sup>nd</sup> Quarter	July-September	15 <sup>th</sup> October
3	3 <sup>rd</sup> Quarter	October-December	15 <sup>th</sup> January
4	4 <sup>th</sup> Quarter	January- March	15 <sup>th</sup> April

Since, Quarter-I of the FY 2014-15, has already been over; therefore you are requested to direct the Civil Surgeon of your respective District to provide the Status Report and Record of Proceedings (Quarter-I) by 24/09/2014 postiviely, as the same is to be sent to GoI, which has already been delayed. If meeting are not held, they may provide the actual status.
